

IHM?

A detailed document outlaying all potentially hazardous material onboard a vessel

- Hazardous material is any substance that can pose a risk to the health and safety of people or to the environment as identified and listed by the Hong Kong Convention (2009)
- Inventory of Hazardous Material (IHM) is a document in which all potentially hazardous material onboard a vessel is identified, located and quantified and follows IMO Resolution MEPC. 269(68)



INTRODUCTION OF REGULATIONS

- » What does the IHM consist of?
 - » 3 Parts
 - » Part I – Ship's Equipment & Structure
 - » Part II – Operationally Generated Waste
 - » Part III - Stores
 - » Part I is required for new buildings and vessels in operation
 - » Part II & III is required when vessel is ready for recycling

MEPC 269(68) Guidelines for the development of IHM

An inventory of hazardous materials in the ship structure and equipment is first priority for all vessels

- IHM is divided in three parts:
 - Ship's structure and equipment*
 - Operationally generated wastes*
 - Stores*
- Part I is handled either during the construction for new vessels or during operation for existing vessels
- Part II and III are developed at the end of the vessel life shortly before it is recycled
- Table A is mandatory for all existing and new vessels while table B is only compulsory for new buildings
- Table C and D are only required for part II and III

EU REGULATION – KEY POINTS AND TIMELINE




» EU SRR TIMELINE

- » By 31 December 2020, all vessels entering EU MUST have IHM on board
 - » *As of now, approximately 20,000 existing vessels require IHM (18 per day)
- » Vessels already having IHM MUST have the IHM updated and maintained
- » EU Flag vessels' IHM MUST include PFOS as a minimum

KEY POINT - NEW BUILDINGS

- » To be prepared by shipbuilding yard or third party
- » Effective earliest 31.12.2015, latest 31.12.2018
- » Introduction of 2 new hazardous materials (PFOS and HBCDD)
 - » Make sure your new buildings are in accordance with the latest EU regulations
 - » To avoid adaptation at a later stage
 - » Bring it into the specifications
- » Metizoft's delivery of IHM newbuildings has been compliant with EU regulations since august 2014.

KEY POINTS – EXISTING VESSELS WITH AN EXISTING GREEN PASSPORT / IHM

- » Convert to EU Regulations
 - » Follow MEPC 269(68) using the patterns for existing vessels
 - » After onboard inspection an initial survey takes place with the purpose of verification
 - » Available MDs and SDOCs of GP/IHM will be used if the docs are still valid
 - » Reduces the scope of inspection onboard
 - » Less expensive for owners who have kept their GP / IHM up to date



KEY POINTS – EXISTING VESSELS WITHOUT AN EXISTING GREEN PASSPORT / IHM

- » 31.12.2020
 - » For both EU flagged vessels and third party ships calling EU ports
- » Haz mat expert on behalf of shipowner
 - » Drydock /certification
 - » To be kept up to date after Statement of Compliance



STANDARD PAIN / FEAR FOR SHIPOWNERS


- » Detention at port state controls
- » Reduced dayrate
- » Court cases/recourse - occupational injury (asbestos)
- » Harmful PR which can cause reputational damage and impact business




